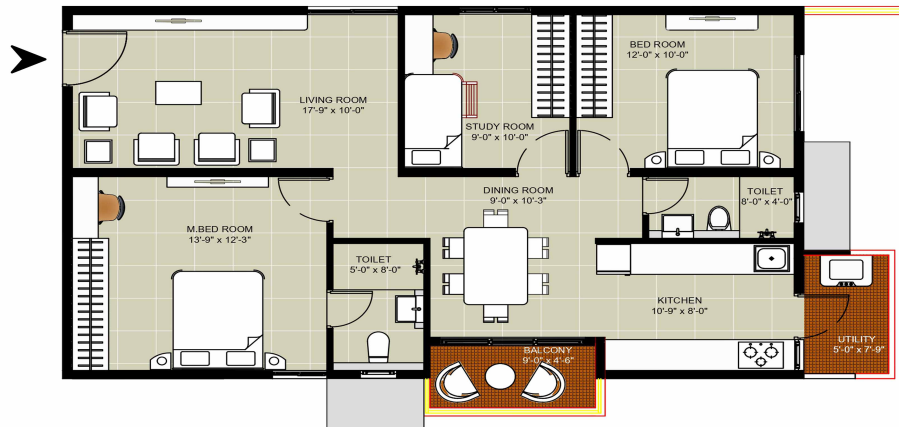

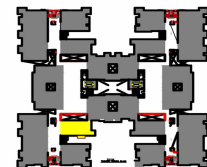

Floor Plan - 2.5 BHK, Saleable Area 1285 Sq Ft.



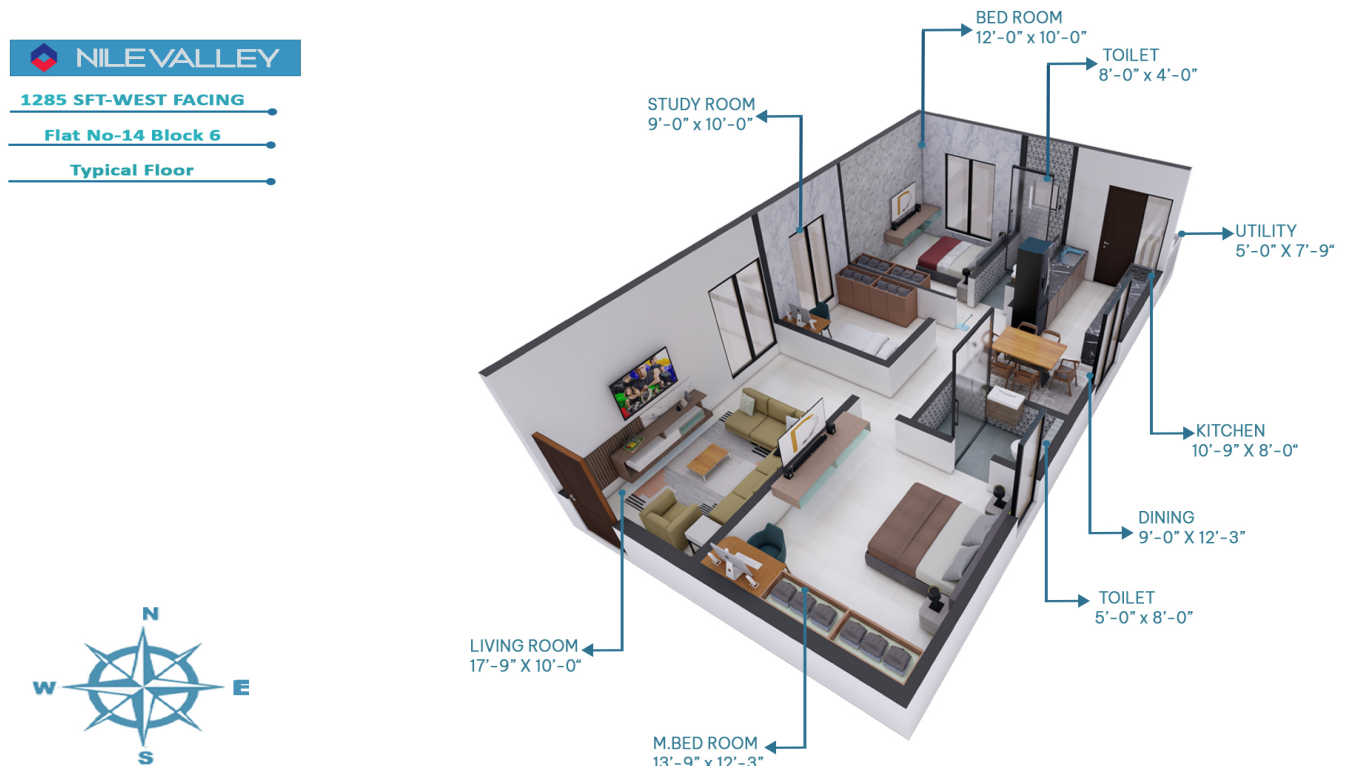
