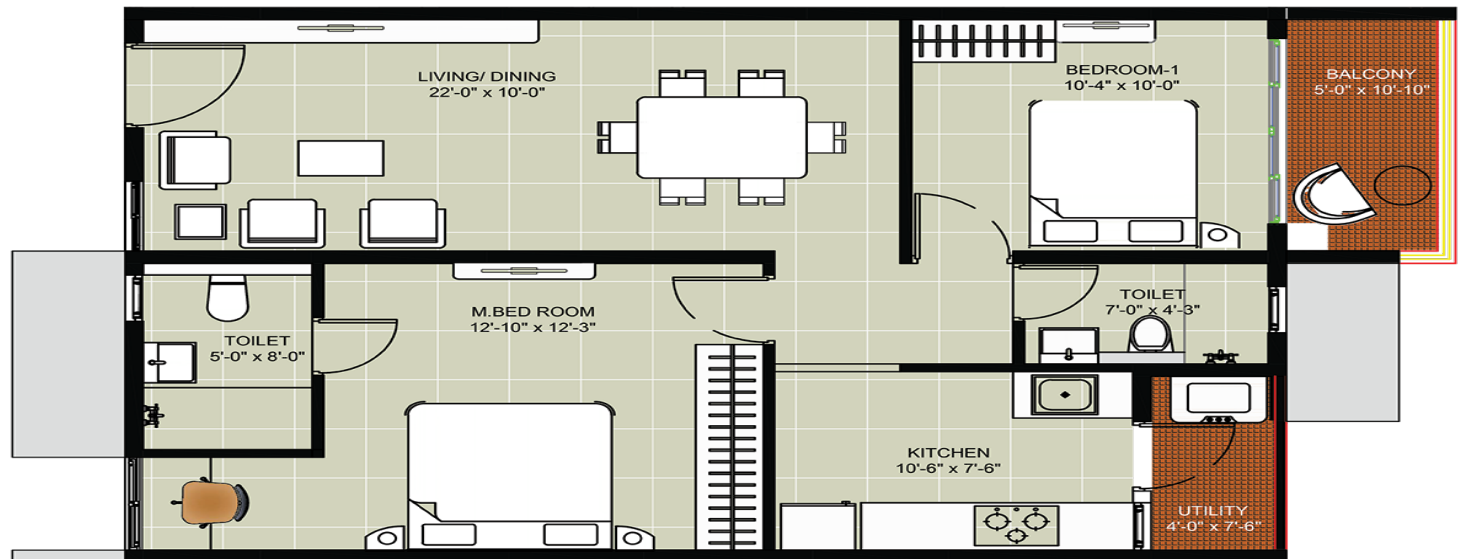

2D Floor Plan



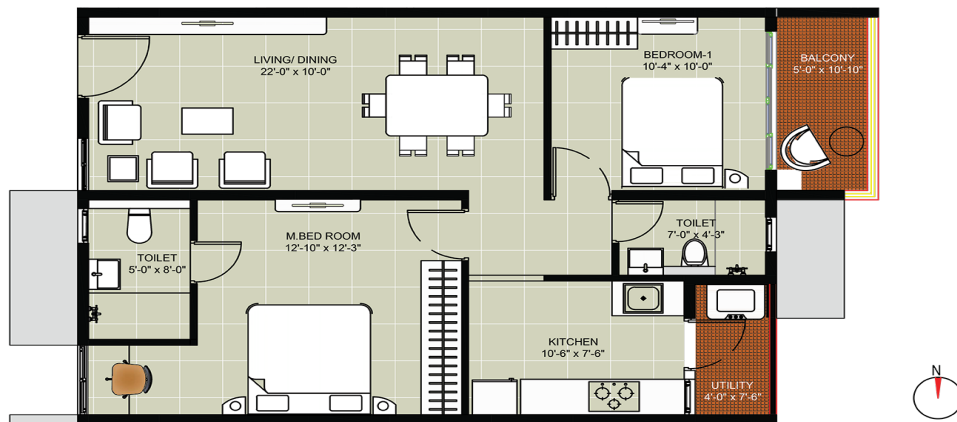
